Sunny Inspire

Sunny Inspire Limited ("Sunny Inspire") provides the following Limited Product Warranty and Limited Power Warranty subject to the conditions, exclusions and limitations as set forth below.

Model Names covered under this warranty

SA-HXX or SA-HXXX SA-ECXX or SA-ECXXX (XX and XXX stand for power output)

Limited Warranty: Materials or Workmanship

Sunny Inspire warrants to the first consumer purchaser that the Sunny Inspire brand PV-panels to be free from defects in materials or workmanship under normal application, installation, use and service conditions. If the product fails to conform to this warranty, then, for a period ending five (5) years from date of sale to the original consumer purchaser, Sunny Inspire will, at its option, either repair or replace the product or refund the purchase price. The repair, replacement, or refund remedy shall be the sole and exclusive remedy provided under this warranty.

Limited Warranty: Power Output

For the said model of PV panels used for off-grid PV application, Sunny Inspire warrants for a period of twenty (20) years from the date of sale to the original consumer purchaser that the power rating at Standard Test Conditions will remain at 80% or greater of Sunny Inspire's Minimum Specified Power Rating.

Sunny Inspire will, at its option, repair or replace the defective product, or provide the purchaser with additional panels to make up lost power, or provide monetary compensation equivalent to the cost of additional PV panels required to make up such loss in power, provided that such degradation is determined by Sunny Inspire (at its sole and absolute discretion) to be due to defects in materials or workmanship under normal off-grid installation, application, and use. The relevant Minimum Specified Power Rating is defined in Sunny Inspire's product data sheet at the time of shipment. Standard Test Conditions are irradiance of 1000 W/m², 25°C cell temperature, and am 1.5 light spectrum.

Exclusion and Limitations

Warranty claims must, in any event, be filed within the applicable Warranty period.

The limited warranties set forth herein do not apply to any panel which in Sunny Inspire's absolute judgment has been damaged through misuse, neglect, accident, abuse, alteration, improper installation or application, or negligence in use, storage, transportation, or handling.

The limited warranties do not cover costs associated with panel installation, removal, testing, packaging, transportation, or reinstallation; other costs associated with obtaining warranty service; or costs, lost revenues, or lost profits associated with the performance or nonperformance of defective panels.

Power Output Limited Warranty claims for PV-panels used in non-land based applications shall in no case exceed ten (10) years.

Any Warranties for any framing and/or mounting system are the sole responsibility of the supplier of those systems.

Sunny Inspire

Warranty claims will not apply if the model number or serial number of the PV panels is altered, removed or made illegible.

Limitation of Warranty Scope

Any panels repaired or replaced by Sunny Inspire under a warranty claim shall be covered by the original warranties and original term of the first product purchased under said claim. The term shall not be prolonged or reset from the date of sale to the original purchase. Any replaced parts or products become the property of Sunny Inspire.

The limited warranties set forth herein are expressly in lieu of and exclude all other express or implied warranties, including but not limited to warranties of merchantability and of fitness for particular purpose, use, or application and all other obligations or liabilities on the part of Sunny Inspire.

Sunny Inspire shall have no responsibility or liability whatsoever for damage or injury to persons or property, or for other loss or injury resulting from any cause whatsoever arising out of or related to the product, including, without limitation, any defects in the panel, or from use or installation. Under no circumstances shall Sunny Inspire be liable for incidental, consequential, special damages, however caused. Loss of use, loss of profits, loss of production, loss of revenues are therefore specifically but without limitation excluded.

Sunny Inspire's aggregate liability, if any, in damages or otherwise, shall not exceed the purchase price paid to Sunny Inspire by the customer, for the unit of product or service furnished or to be furnished, as the case may be, which gave rise to the warranty claim.

Force Majeure

Under no circumstances shall Sunny Inspire be liable for acts of God, power failures, lightning, fire, flood, severe weather, hailstorms, insect and pest infestation, and other events, howsoever caused, reasonably beyond Sunny Inspire's control, including, without limitations, any technological or physical event or condition which is not reasonably known or understood at the time of sale.

The solar panel with model number SA-HXX or SA-HXXX (XX and XXX ranged from 30 to 170) shall not be used for applications that connect to the utility electricity grid and Sunny Inspire has no liability, and all warranties shall be voided, to the extent the panels are used in any such application.

Warranty Claim Procedure

If the customer feels a justified claim is covered by this limited warranty, he/she must immediately submit a written claim to (a) the dealer who sold the PV-panels, or (b) any authorized Sunny Inspire distributor, or (c) Sunny Inspire Limited. Rm 1505, 15/F Star House, No. 3 Salisbury Rd, Tsim Sha Tsui, Kowloon, Hong Kong.

Adequate documentation of proof of purchase of the solar panel is required for Warranty Claims to be processed. Purchase receipt, serial no. and panel label and detailed description of product failure. Sunny Inspire will determine in its sole judgment the adequacy of such claim.

If applicable, the customer's dealer or distributor will give advice on handling the claim. If further assistance is required.
